## DCRP/MP/19/09 - EREC P24 Issue 2 AC traction supplies to British rail

Any further development to P24 will be delayed to align with P29 expected publishing – P29 is currently undergoing review by members. P24 Issue 2 has seen majority of members of the group in agreement, with a further update being provided by the end of February.

## DCRP/MP/20/04 - Data Exchange WG

EREC G111 and set of corresponding schedules has been delivered by this workgroup, member companies are providing comment, with a workgroup review meeting scheduled to discuss and agree any amendments before a 12 month trial period begins 01 April 2023.

#### DCRP/MP/22/02 - Electricity System Restoration Standard

Public consultation responses are currently being assessed. Alignment with Grid Code modification GC0156 is planned, with any further consultations and submission of the Report to Authority mirroring the dates of this modification.

# DCRP/MP/22/03 / 04 - EREC P2 Issue 8 and EREP 130 Issue 4 Security of Supply

### Guidance on the application of Engineering Recommendation P2, Security of Supply

The Authority has approved both EREC P2 Issue 8 and EREP 130 Issue 4. Both documents have been published through the ENA's document catalogue.

#### DCRP/MP/22/05 - Customer Islanding

The workgroup nominations have gone out to members and Stakeholders, with positive engagement from key industry parties. Initial workgroup meeting is scheduled for mid-February.

## <u>DCRP/MP/22/06 - EREC G12 Issue 5</u> Requirement for the Application of Protective Multiple Earthing to Low Voltage Networks

EREC G12 Issue 5 has been prepared by the workgroup (Earthing Co-ordination Group). The public consultation paper is being drafted and scheduled for release late February 2023.

#### DCRP/MP/23/01 - EREC P28 Issue 3

Voltage fluctuations and the connection of disturbing equipment to transmission systems and distribution networks in the United Kingdom

Workgroup nominations have been agreed, a draft Terms of Reference has been prepared. A 'scoping out' meeting is arranged with the DNO members and will set out the areas of EREC P28 for revision to include elements of BESS connections.

Once complete a stakeholder inclusive workgroup will be developed to commence the revision stage of this modification.
