### **DCRP/MP/19/09 - EREC P24 Issue 2 AC traction supplies to British Rail**

This modification is progressing, engagement with National Rail is ongoing regarding the proposed amendments to EREC P29 which will be prepared to publish alongside EREC P24. Further updates will be provided.

### **DCRP/MP/20/04 - Data Exchange WG**

The trial period is ongoing, information is being gathered by members and schedules filled out. A review meeting to assess with the workgroup is planned for Q3 2023. Further updates to follow.

### **DCRP/MP/22/02 - Electricity System Restoration Standard (ESRS)**

The second consultation on the proposed changes has closed, all comments have been assessed and the Report to authority prepared for the Panel.

### **DCRP/MP/22/05 - Customer Islanding**

Development of the legal text is progressing. The workgroup is currently focused on developing a range of diagrams to provide clarity, and considering the compliance requirements for devices which facilitate customer islanded premises.

### **DCRP/MP/23/01 - EREC P28 - Engineering Report (EREP) Voltage fluctuations and the connection of disturbing equipment to transmission systems and distribution networks in the United Kingdom**

The workgroup is developing a set of clauses for the EREP and has agreed that the guidance provided will be explanatory in nature. This work is being progressed with a DCode modification reference until no consequential changes to P28 can be confirmed.

Stakeholder views on specific requirements of EREC P28 have been collated and the workgroup is currently developing a set of responses to be communicated with the relevant stakeholders.

### **DCRP/MP/23/02 – Revision to the Constitution and Rules of the DCRP**

A draft copy of the Constitution and Rules document has been prepared for panel, changes to the text include a revision to membership representation; allowing each DNO to hold a place on the panel.

Consequential amendments approved by the authority under DCRP/MP/21/07 have been integrated into the draft legal text for panel's approval.

### **Modification to DOC6 to allow protection for sites when implementing demand disconnection where technically feasible**

The consultation is currently ongoing and will close 17:00 Friday 18<sup>th</sup> August. Approval in principle to submit the Report to Authority will be sort at the Panel meeting.
