FK and PL presented slides to the panel, providing an overview of progress so far and an update on the timeline. The panel then presented questions on the intent and planned meetings to develop this program further.

4. Grid Code Issues

AC provided a short update on the items of interest from the latest Grid Code meeting held May 2022.

GC0117	Harmonisation of Large, Medium and Small Power Stations - Consultation is due early July, NGESO have published a document on data exchange at DER level. ENA confirmed it was available to prepare a draft response to the NGESO consultation due to close on 8 th July.
GC0139	Enhanced Planning Data Exchange - Progress is ongoing.
GC0148	Emergency and Restoration Code Phase II - Implications on DNOs from this modification have been transferred to GC0156.
GC0156	Electricity System Restoration Standard - Work is ongoing to develop this modification and joint working groups.

5. EU Network Codes

5.1 EN 50549-10

A verbal update was provided to the panel on the status of EN 50549-10. A draft version has been issued, a review of the appendices of EREC G98 and G99 will be required once this document is published.

6. DCode User Issues

6.1 Standard Application Form

Version 8 has now been published along with individual sections available for stakeholders to download from the DCode website.

7. Ongoing DCode/Grid Code Modifications - Updates

7.1 DCRP/MP/21/07 - EU Exit Modification

The final report to authority was prepared and has been sent to Ofgem for decision. If approved version 50 of the DCode will be published with all changes included.

If approved the DCRP/MP/21/07 agenda item will be removed from future meeting documents.

Work is ongoing in the drafting of EREC P24, in-line with EREC P29. Once complete, these documents will be published simultaneously.

7.4 DCRP/MP/20/04 - Data Exchange working group

Member companies have now returned comments on the draft document and schedule and the working group is assessing the feedback before progressing.

A call has been arranged with the INA to present the work for any comment, once returned a consultation document can be drafted.

A copy of each document will be circulated for comment before public release.



12. Loss of Mains Change Programme

GS provided a verbal update to the panel, the program currently has 7GW of generation remaining and a total of 3GW is predicted when the program closes on 31st August 2022. Although not all of that total will be non-compliant generation, enforcement with the DCode post the closure date will need to be managed effectively.

Approaches for managing the remaining 3GW of generation are currently being discussed, one option is the introduction of a threshold below which generation with no material effect on the distribution network will be exempted from complying with G59/3-7. A meeting will be arranged to discuss further. One of the outcomes from this work would be to prepare amendments to ER.
