The defined terms within the document for DNO and IDNO were discussed and the use of the term 'OAD' was discussed, it was agreed the term is not required in the title of the document as DNO is inclusive of OAD already. After this discussion it was agreed to review the use of DNO, IDNO and OAD to ensure the terms are used in the correct context throughout the document.

During the review it was proposed to enlarge the text used in figure 1. CMc to follow up. Clarity on the 'other publications' section placement in the document was given, any relevant documents will be listed in the normative section of the document.

Revised schedules

The WG discussed proposed title amendments for each of the schedules. These titles were agreed in principle. Minor amendments discussed were made to the schedules.
